TOURNAMENT RULES

The Essex County Mixed Doubles Tournament is governed by the rules of the United States Bowling Congress (USBC).In addition, the following rules and regulations have been adopted by the Usbc Wba & Ba of Essex County

- 1. A team must consist of one man and one woman. All entrants must be sanctioned by USBC this season and one member must have a Essex County Book Average for 2015/2016 or currently bowling in a Essex County League this season.**
- 2. Each captain must check in with the tournament management at least 30 minutes prior to receive their lane assignment and present a current USBC membership card.**
- 3. Any player or team arriving after a squad has started will be permitted to bowl in the frame being bowled but will not receive any score for unbowed frames. Late bowlers will not be permitted any practice. Substitutes who start must complete that game.**
- 4. All entrants will use their highest Essex county Book Average based on 21 games or more in this order:
(a) Highest Book Average from Essex County from the 2015/2016 season.
(b) If no 2015/2016 Book Average, use the 2016/2017 current average as of Nov. 8th for 12 games or more.
© Summer averages for 2015/2016 for 21 games or more may be used, provided a final average sheet is Presented or verification by League Secretary for the summer of 2016.
(d) Any entrants without any of the above options must bowl scratch on a figure of 230 for men and 190 for Women. Designate on entry form the source of average by use of (a), (b), ©, (d). All averages will be verified. Entrants using options (b) & © must submit average verification prior to bowling.
No exceptions will be made!!!!**
- 5. Failure to use the proper average or make a corrections prior to the completion of the first game shall disqualify the score if the average is lower than the entrants average. If higher, the average will be used.**
- 6. USBC "Tournament Prize Winnings" 319D or the 10 pin rule DO NOT APPLY. USBC rule 319-2 rerating Is waived as well a USBC rule 319e covering 15 or more increase in average**
- 7. Each team will be given a handicap of 100% of the difference between the total team average and 460 per game. Each team average over 460 will receive no handicap.**
- 8. Only gross scores for teams will count for cash prizes. No individual awards will be made for this Tournament EXCEPT USBC HIGH SCORE AWARDS.**
- 9. In the event of a tie for first place, co-champions will be declared. All other prize money for tied positions will be combined and divided equally among the teams involved.**
- 10. Bowlers must bowl in the order listed on the entry form.**
- 11. Any appeal or protest must be submitted, in writing, and will be decided by the tournament committee. All prizes will be distributed in 30 days following the tournament, providing a average verifications have Been completed. Decisions of the committee are final unless a appeal is made (USBC rule 329).**
- 12. Teams making reservations, call the Tournament director. However, applications must be in by the Closing Date 11/20/16 2:45, if lanes are available. The management reserves all rights.**
- 13. Bowl as often as you wish. Cash only once with the same partner. (pots will be held if requested)**
